COMPLIANCE REPORT OF SPECIFIC & GENERAL CONDITIONS OF THE ENVIRONMENT CLEARANCE GRANTED BY MINISTRY OF ENVIRONMENT AND FORESTS. NEW DELHI FOR FERRO ALLOY PLANT (14,400 TPA) WITH BIO - MASS BASED (RICE HUSK) POWER PLANT (08 MW) BY M/S. SHRI BAJRANG POWER AND ISPAT LIMITED AT VILLAGE: BOJHARA, DISTRICT: RAIPUR (CG).

A. SPECIFIC CONDITIONS STATUS AS ON 31/03/2025

Sr. No.	Compliance Conditions	Status 31.03.2025
i.	Electro Static Precipitator (ESP) along with plus jet bag filters shall be installed in the hoper instead of cyclone and wet scrubbers to control emissions with 50 mg/Nm3.	One no. ESP is installed in AFBC based Biomass power plant and Two no. Pulse Jet Bag Filters are installed in Ferro alloys units to control and maintain the emission level within 50 mg/Nm3.
ii.	In-plant control measures for checking fugitive emissions from all the vulnerable sources shall be provide. Fume and dust extraction system with bag filter shall be provided at the material transfer and discharge points to control fugitive emissions. Further, specific measures like water sprinkling around the coal stock piles asphalting or concreting of the roads shall be done to control to reduce the dust generation and fugitive emission during handling.	Fugitive emission is being controlled by regular operation of Mist water spray system, installed at closed conveyor belts circuits and other areas. Permanent & movable water sprinklers are also installed at required locations. Covered conveyor belt circuits of material transfer & discharge points, connected with dust extraction system & Bag filters. All internal roads are RCC/Concrete blocks and same are being cleaned by Mechanical sweeping machine and water sprinkling is also being done on these roads, raw material yard and other area on regular basis by water tanker to control dust generation during process and vehicle movements. We have also constructed wheel wash system at near main gate in order to control fugitive emission due to vehicle movements. photographs enclosed as Annexure - I.
iii.	Secondary fugitive emission from all the sources including existing Sponge Iron plant and captive power plant shall be controlled within the latest permissible limits, issued by the Ministry and regularly monitored. Guidelines/code of practice issued by the CPCB shall be followed.	Secondary fugitive emission from all the sources including existing Sponge Iron plant and Captive power plant is being controlled and maintained well within the latest prescribed norms, by installation and effective operation of installed Air Pollution control equipment's. Guidelines/code of practice, issued by the CPCB are being followed.
iv.	Total water requirement from River Kharun/Shivnath shall not exceed 2940 M3/day. No water shall be sourced from the ground water sources. All the acidic and alkaline effluent shall be neutralized in neutralization tank and treated effluent shall be recycled/reused in the process and Green belt development. Cooling Tower blow down shall be used for dust suppression in fuel handling area. Domestic waste water shall be treated in septic tank followed by soak pit. No waste water shall be discharged outside the factory premises and Zero discharge shall be adopted.	Agreed and being followed. No ground water is being used for process. We have obtained NOC from Central Ground water, Jamnagar House, man singh Road, new delhi vide letter no. CGWA/NOC/IND/REN/2024/9081 dated 12/02/2024 valid up to 04/01/2027 for withdrawal of 75 KLD ground water only for Drinking & Domestic purpose. Surface water from Kharun River is being used for industrial purpose after obtaining permission from authorized agency. Industrial discharged water & Cooling Tower blow down is being used for dust suppression in fuel handling area, Fly Ash loading/unloading

		area and on our internal roads. Domestic discharge water is being treated in septic tank followed by soak pit. Generated waste water is not being discharged outside the factory premises; hence Zero discharge is being maintained all the time.
v.	Prior permission for the drawl of 2940 M3/day water from Kharun River from the concerned department shall be obtained.	We have obtained permission for the drawl of 2940 M3/day water from Kharun River by water resource department, Mantralaya Raipur (C.G.) vide their letter 5010/302/WR/TECH/03/IWS/D-4 dated 26.10.2004.
vi.	All the granulated slag shall be providing to cement/Brick manufacturers for manufacturing Pozzolana slag cement (PSC) or making Bricks. No Granulated slag shall be used for road constructions and filling low lying areas. All the char, Dolochar shall be used in AFBC Boiler. Hexavalent Chromium present in the slag shall be converted in to trivalent Chromium. Ferro chrome shall be stored in secured landfill as per the CPCB guidelines. Bottom ash shall be disposed off suitably designed land fill as per CPCB guidelines to prevent leaching of sub soil and underground aquifer. ETP sludge after drying shall be used as a fertilizer for green belt development. Used oil shall be sold to recyclers and pre-processers.	Generated slag from Ferro Alloys unit after crushing, screening and material removing is being used in our Fly Ash Bricks plant. Bottom ash from 08 MW Biomass Power Plant is also being used in our Fly Ash Bricks plant as a raw material. Generated Used oil is being used for lubrication in Roller conveyor as well as Belt conveyors of the plant and balance if any, is being sold to recyclers /authorized agencies. All generated char/Dolochar from our SID unit is being used in our AFBC boiler of Borjhara and Gondwara unit.
vii.	All the Fly ash shall be utilized as per Fly Ash Notification, 1999 subsequently amended in 2003.	Agreed and is being utilized as per Fly Ash notification.
viii.	Out of total 21 Hectare green belt shall be developed in 7.0 Hectare (33%) within and around the plant premises as per the CPCB guidelines in consultation with DFO.	Agreed and is being developed & maintained as per the CPCB guidelines and Plant species in consultation with DFO has been planted. Plantation Pictures attached as Annexure - II
ix.	All the recommendations made in the charter on Corporate Responsibility for Environment Protection (CREP) for the Ferro Alloy plants should be implemented.	Agreed and being implemented.




ii.	No further expansion or modifications in the plant shall be carried out without prior approval of the Ministry of Environment and Forest.	Noted and Agreed. For future expansion or modification in the plant, prior approval will be taken from MoEF&CC.
iii.	The gaseous emissions from various process units shall conform to the load / mass-based standards notified by this Ministry on 19 th May, 1993 and standards prescribed from time to time. The CECB may specify more stringent standards for the relevant parameters keeping in view the nature of the industry and its size and location. At no time, the emission level shall go beyond the prescribed standards. Interlocking facilities shall be provided so that process can be automatically stopped in case emission level exceeds the limit.	Noted and Agreed. Inter locking system has been provided which can trip raw material feed to process equipment, in case of non-working of pollution control equipment. The treated waste water shall be utilized for plantation purpose.	Agreed and Being Complied. Plant Discharge water after treatment by settling tank is being used for dust suppression and Plantation purpose.
vii.	The overall noise levels in and around the plant area shall be kept well within the standards (85 dBA) by providing noise control measures including acoustic hoods, silencers, enclosures etc. on all sources noise generation. The ambient noise levels should conform to the standards prescribed under EPA Rules, 1989 viz. 75 dBA (day time) and 70 dBA (night time).	Agreed and being followed. However personal protective equipment like ear plugs are being provided to concerned employees of Noise prone area. The ambient noise level is maintained well within the latest prescribed norms. viii.	Occupational health surveillance of the worker shall be done on regular basis and record maintained as per the factories Act.	Agreed. Annual Medical checkup of all the employees are being carried out and records are being maintained. Company has constructed a own "Occupational health Centre with well qualified & experience medical staff within plant premises". Copies of Medical checkup report of employee for

ix.	The company shall develop surface water harvesting structures to harvest the rain water for utilization in lean season besides the recharging the ground water table.	Agreed and being maintained. There are 5 nos. Rain Water Harvesting Pits have been constructed inside the plant premises at different location. In which 5 nos. injection wells for recharging of both surface runoff and roof top water. Photographs enclosed as Annexure - VII
x.	The project proponent shall also comply with all the environmental protection measures and safeguards recommended in the EIA/EMP report. Further the company must undertake socio-economic development activities in the surrounding villages like community development program, educational program, drinking water supply and health care etc.	All the environmental protection measures and safeguards recommended in the EIA/EMP report and socio-economic development activities like community development programs, educational programs, drinking water supply and health care etc. are being conducted in the surrounding villages under CSR program by us.
xi.	The project authorities shall provide Rs.5.00 Crores and Rs. 30.00 Lakhs earmarked towards the capital cost and recurring cost/ annum for environment pollution control measures and used judiciously to implement the conditions stipulated by the ministry of environment and forests as well as the state govt. 


